- ✓ The maximum annual contribution for the 2016 tax year is \$25,370. However, we recommend that you refer to your Notice of Assessment provided by Canada Revenue Agency (CRA), which states your maximum contribution for 2016 based on your personal tax situation.
- ✓ The maximum contribution for the 2017 tax year is \$26,010.
- ✓ The Maximum Contribution Limit remains equal to the lesser of the threshold amount or 18% of the individual's previous year's earned income.

Spousal RRSP Rules

- Any amount that may be contributed to an individual's own plan under their personal RRSP deduction limit may be contributed to a spousal RRSP instead.
- Contributions to a spousal RRSP may be made by a contributing spouse up to and including the year their spouse turns 71 (tax deductible to contributing spouse), provided the contributor has available RRSP room.
